## B. What personal data do we collect?

When you sign up for our services such as Software Development and Advisory we collect, your name, name of the company, address, position in the company, telephone number and/or mobile phone, email address, any necessary credentials and/or codes and/or access to data and V.A.T number. Once you provide us with this information we may now have communication regarding the task you have instructed us to do and add you in our list of contacts.

When you sign up for our services such as Training we collect your name, address, telephone and/or mobile phone, email address, name of the company, experience, titles and Curriculum Vitae, and any recent or previous programs or seminars you have attended.

When you sign up as our supplier you can provide us with your name, address, e-mail address, phone number and fax. Once you provide us with this information you have the option of communication.

Whenever you visit our webpage, we collect information that your browser sends to us that is called Log Data. This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser version, manufacturer, model, operating system, browser type, device identifiers, pages of our Service that you visit, the time and date of your visit, the time spent on those pages, and other statistics.

### Cookies

1. RIGHT TO BE INFORMED

You are entitled to know:

- Who keeps your personal data?
- For what purpose?
- For how long? Are there any recipients?

2. RIGHT OF ACCESS



If you wish, you can ask in writing to find out which of your personal data has been collected by the Company. We will respond in writing to your request within four (4) weeks.

## 3. RIGHT OF RECTIFICATION

If you realise that the personal data collected is incorrect or if you have updated or renewed your data, then please contact us at <u>aloizou@gbeat.io</u> to rectify your details.

# 4. RIGHT TO BE FORGOTTEN (OR ERASURE)

Beyond the right of rectification, you also have the right to erase the links around your name if they are incorrectly posted on the internet. If you wish, please contact <u>aloizou@qbeat.io</u>, which may inform you of what measures can be taken.

# 5. RIGHT TO RESTRICTION OF PROCESSING

You must be aware that your data can only be collected for a specific purpose as well as for a certain period of time.

### 6. RIGHT TO OBJECT

On the basis of your rights, you may request that your data be corrected or deleted by a public or private body which must reply in writing within 15 days. Rejection is notified. If you have not been satisfied with the response you have received then you further have the right to contact the Office of the Commissioner for Personal Data and file a complaint with them.
